

## **May 1, 2006**

The Board of Brown County Commissioners met in regular session with the following members present: Chairman Warren Ploeger, Steve Roberts and Glen Leitch. Also present was County Clerk Debbie Parker and Deputy County Clerk Marla Hathhorn.  
Warren Ploeger opened the meeting at 8:00 a.m.

### **SHERIFF**

Sheriff Lamar Shoemaker reported a leak in the jail roof in dispatch. Shoemaker was instructed to contact KB Roofing in Fairview, who had received the bid for the jail roof.  
Shoemaker also presented the Johnson County Inmate Contract, which charges \$35.00 per day per inmate. Motion by Steve Roberts to approve the contract. Seconded by Glen Leitch. Motion carried.

### **ROAD FOREMAN**

Road Foreman Mel Werner discussed road projects.

### **ROAD OILING**

Glen Leitch reported a taxpayer had questioned him in regards of the County Criteria Plan for oiling roads. Warren Ploeger stated that there is no set formula for oiling of roads and he is not in favor of forming a criteria policy, as there would be too many variables. Steve Roberts agreed with Ploeger. Traffic counts were discussed; KDOT performs a traffic count every 3 years, Brown County does not perform traffic counts.

### **HEALTH DEPARTMENT**

Motion by Glen Leitch to approve the Brown County Health Department March report. Seconded by Warren Ploeger. Motion carried.

Area Agency on Aging Director Jim Beckwith presented a proclamation declaring May 2006 as "Older American Month." Motion by Warren Ploeger to approve the Proclamation. Seconded by Glen Leitch. Motion carried. Beckwith reported that every 7 seconds a Baby Boomer turns 60 years of age.

### **LARRY GUAGLIARDO**

Hamlin resident Larry Guagliardo, discussed problems in the City of Hamlin including dogs and cats running loose and a yard full of junk cars. Warren Ploeger will contact Hamlin City Mayor Dale Bosse, as the problem would be under Hamlin City jurisdiction.

### **BUREAU OF INDIAN AFFAIRS**

John Briscoe, Bureau of Indian Affairs, presented a proposed agreement to replace Bridge #OS40 on the Stateline road. The agreement will require Brown County and Richardson County Nebraska to be responsible for the bridge design and BIA will provide the funding.

### **MARILYN MOYNAGH**

The Commissioners congratulated Brown County Treasurer employee Marilyn Moynagh on her retirement after 19 years of service to Brown County. The Commissioners thanked her for her dedicated service to the County.
